It is further expressly agreed that throughout this Warranty the term "Owners" shall include the employees and agents of the Owners of the said vessel whether at sea or ashore and any person whom the said Owners may be liable to indemnify in respect of such claims whether in contract or otherwise.

This indemnity is governed by and construed in accordance with Italian law and any dispute arising out of or in connection with this Release shall be subject to the exclusive jurisdiction of the Courts in Italy.
